Swindon Borough Council has resolved to produce a draft Supplementary Planning Document on the following issue:

- Proposed Swindon Eastern Development Area

Copies of the draft Supplementary Planning Document (SPD) and its accompanying Sustainability Appraisal (SA) are now available for public inspection and comment at Swindon Borough Council Customer Services at Premier House, Station Road, Swindon or Wat Tyler House, Beckhampton Street, Swindon free of charge (Monday to Friday 9.00 a.m. to 4.30 p.m.). The document may also be viewed at all libraries within Swindon Borough, during normal opening hours of those libraries, and can also be viewed on the Borough's website at: [www.swindon.gov.uk/spd](http://www.swindon.gov.uk/spd).

The consultation period commenced on **Monday 20<sup>th</sup> April for an eight week period, ending on Monday 15<sup>th</sup> June**. The aim of the consultation is to allow anyone who is interested in the long-term planning and growth of Swindon, particularly the EDA, to make their views known.

In the consultation period Council Officers will be attending Local Parish meetings and putting on a series of public exhibitions. The public exhibitions will take place on the following dates at the venues stated:
