Swindon Borough Council does not charge for signing declarations. However, all other administration of the ECO Flex scheme is carried out by the Centre for Sustainable Energy and they charged a fee to cover their costs. The fee during ECO3 was £50 for a single measure and £100 for a dual measure per property. The fee was benchmarked against other admin fees for ECO Flex schemes in other areas.
