**THE SWINDON BOROUGH COUNCIL
FOOTPATH 35 CENTRAL SWINDON NORTH MODIFICATION ORDER 2025**

This Order is made by Swindon Borough Council ("the authority") under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Swindon Borough Definitive Map and Statement require modification in consequence of the occurrence of events specified in section 53(3)(c)(i) of the 1981 Act, namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path.

The authority has consulted with every local authority whose area includes the land to which the Order relates.

Swindon Borough Council hereby orders that:

- 1 For the purposes of this Order the relevant date is 30 April 2025.
- 2 The Swindon Borough Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
- 3 This Order shall take effect on the date it is confirmed and may be cited as the Swindon Borough Council Footpath 35 Central Swindon North Modification Order 2025.

MODIFICATION OF THE DEFINITIVE MAP

(References to lettered points in the following descriptions are references to letters on the attached maps showing the paths or ways being described. All distances are approximate. All descriptions are of "footpaths" unless otherwise stated)

Parish	Path no.	Description of path to be added	Modified under S.53(3) as specified
Central Swindon North	35	A length of path which commences at Pinehurst Road, at OS grid reference SU14898628, adjacent to the northern boundary of 48 Pinehurst Road, (Point A) and leads generally east south east and then eastwards around the south side of the sports pavilion for 80 metres to then turn northwards for 55 metres to enter woodland at OS grid reference SU14998631, continuing generally east north east for 255 metres, crossing stone bridges at OS grid references SU15078632 and SU15138633, to Point B at Public Bridleway 6 at OS grid reference SU15248639, having a width of 2 metres between Points A and B, as shown on the Order Map.	53(3)(c)(i)

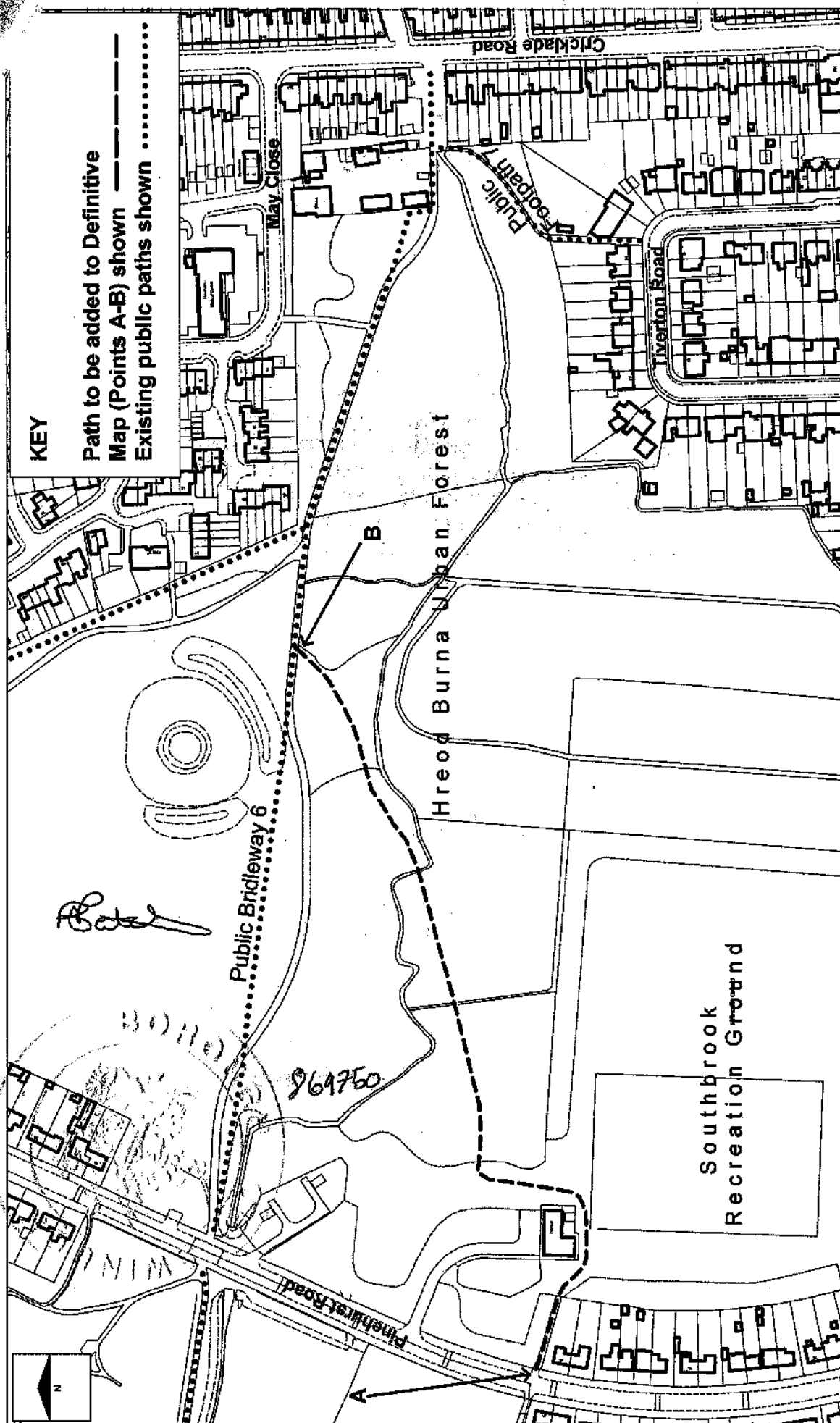
