adding the bridleway

from the eastern end of bridleway no.31 in the parish of Chiseldon at the Ogbourne St George parish boundary (point A on the attached plan) west-north-west along the track leading towards Barbury Shooting School as far as grid ref. SU16957643 (approx.) where an old finger post stands (point B on the attached plan) and then left, initially in a westerly direction then south then westwards into the open field at point D on the attached plan and then generally westwards to the Wroughton to Barbury Castle road at grid reference SU15737620 (approx.) (point C on the attached plan)

and **adding** to the particulars relating to the bridleway

from the eastern end of bridleway no.31 in the parish of Chiseldon at the Ogbourne St George parish boundary (point A on the attached plan) west-north-west along the track leading towards Barbury Shooting School as far as grid ref. SU16957643 (approx.) where an old finger post stands (point B on the attached plan) and then left, initially in a westerly direction then south then westwards into the open field at point D on the attached plan and then generally westwards to the Wroughton to Barbury Castle road at grid reference SU15737620 (approx.) (point C on the attached plan)

by providing that its width is 5 metres between points A and B and its width is 6 metres between points C and D and its width is 4 metres between points B and D
