## SWINDON BOROUGH COUNCIL (VARIOUS ROADS, SWINDON) (SPEED LIMITS) CONSOLIDATION ORDER 2022 (VARIATION NO. 9) 2025

Swindon Borough Council in exercise of their powers under Sections 82(2), 83(2) and 84(1),(2) and part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with PartIII of Schedule 9 to the Act, hereby make the following Order:-

- The Order shall come into operation on the xxth day of xxxxxx 2026 and may be cited as the "Swindon Borough Council (Various Roads, Swindon) (Speed Limits)

  Consolidation Order 2022 (Variation No. 9) Order 2025".
- The Swindon Borough Council (Various Roads, Swindon) (Speed Limits) Consolidation Order 2022 is hereby varied as follows:
  - A) By the revision of the plans marked tile reference "AG45, AH44, AH45, AI42, AI43, AJ40, AJ41, AK41, AL41 and AM41".
  - B) The effect of the Order is as follows:

Revoke the 30mph speed limit and introduce a 20mph speed limit on the C142 from 125 metres west of the junction with Bellingham Lane to 260 metres in a north-eastly direction to the eastern kerbline of Roves Lane.

Revoke the national speed limit on the following roads and introduce a 40mph speed limit:


C142 - from a point 583 metres west of Bellingham Lane junction for a distance of 555 metres in a westerly direction.


Supermarine Road for its entire length


Highworth Road - from the junction of Supermarine Road for a distance of 705 metres in a southerly direction


Highworth Road - from the junction of Supermarine Road for a distance of 200 metres in a northerly direction




Key to Restriction Types Displayed
