

**STATUTORY DECLARATION**

**SECTION 31(6) OF THE HIGHWAYS ACT 1980**

We, EDWARD HARTLEY, PHILIP BROUARD, ALEXANDER FREDERIK HERZER all of 43 Lancaster Gate, London W2 3NA as trustees for and on behalf of the Family Federation for World Peace & Unification DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. We are and have been since August 1975 the owner of the land known as Stanton Fitzwarren Estate more particularly delineated on the map accompanying this déclaration and thereon outlined.
2. On the 3rd day of December 2003 Moore Allen & Innocent deposited with Swindon Council, being the appropriate Council, a Statement accompanied by a map delineating my property outlined which stated that the ways coloured red on the said map and on the map accompanying this déclaration had been dedicated as footpaths no other ways had been dedicated as highways over my property.
3. No additional ways have been dedicated over the land outlined on the map accompanying this déclaration since the Statement dated 3rd December 2003 referred to in 2. other than those footpaths marked in red on the map accompanying this déclaration and at the présent time we have no intention of dedicating any more public rights of way over Family Federation for World Peace & Unification property.
