THE SWINDON BOROUGH COUNCIL FOOTPATH 19A HIGHWORTH MODIFICATION ORDER 2015

This Order is made by Swindon Borough Council ("the authority") under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Highworth Rural District Definitive Map and Statement require modification in consequence of the occurrence of events specified in section 53(3)(c)(i) of the 1981 Act, namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path.

The authority has consulted with every local authority whose area includes the land to which the Order relates.

Swindon Borough Council hereby orders that:

- 1 For the purposes of this Order the relevant date is 1 July 2015.
- The Highworth Rural District Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
- This Order shall take effect on the date it is confirmed and may be cited as the Swindon Borough Council Footpath 19A Highworth Modification Order 2015.
