**THE SWINDON BOROUGH COUNCIL FOOTPATH 75 WROUGHTON
MODIFICATION ORDER 2006**

This Order is made by Swindon Borough Council under Section 53 (2) (b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that Authority that the Swindon Borough Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53 (3) (b) of the Act, namely, the expiration, in relation to any way in the area to which the map relates, of any period such that the enjoyment by the public of the way during that period raises a presumption that the way has been dedicated as a public path.

The authority has consulted with every local authority whose area includes the land to which the order relates.

Swindon Borough Council hereby orders that:

- 1 For the purposes of this Order the relevant date is 1 August 2006.
- 2 The Swindon Borough Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
- 3 This Order shall take effect on the date it is confirmed and may be cited as the Swindon Borough Council Footpath 75 Wroughton Modification Order 2006.

PART I

MODIFICATION OF THE DEFINITIVE MAP

(References to lettered points in the following descriptions are references to letters on the attached map showing the path being described. All distances are approximate.)

DESCRIPTION OF PATH TO BE ADDED

Footpath 75 Wroughton

The path which commences on Priors Hill, Wroughton at the gate at the entrance to field OS number 6014 at grid reference SU 414674 180273 (point A), and runs in a generally south-south-westerly direction diagonally uphill across the field for 300 metres to 12 metres north of the south-western corner of the field at grid reference SU 414554 180015 (point B).

PART II

MODIFICATION OF DEFINITIVE STATEMENT

VARIATION OF PARTICULARS OF PATH

Footpath 75 Wroughton

The description of this path shall be:

From Priors Hill Wroughton at the entrance to Field OS No. 6014, leading south-south westwards diagonally uphill across the field to 12 metres north of the south-western corner of the field.

Approximate length: 300 metres

Width: 2 metres

Limitations: a gate at point A and a stile at point B
