## THE SWINDON BOROUGH COUNCIL FOOTPATH 78 WROUGHTON MODIFICATION ORDER 2007

This Order is made by Swindon Borough Council under Section 53 (2) (b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that Authority that the Swindon Borough Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53 (3) (b) of the Act, namely, the expiration, in relation to any way in the area to which the map relates, of any period such that the enjoyment by the public of the way during that period raises a presumption that the way has been dedicated as a public path.

The authority has consulted with every local authority whose area includes the land to which the order relates.

Swindon Borough Council hereby orders that:

- 1 For the purposes of this Order the relevant date is 3rd October 2007.
- 2 The Swindon Borough Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
- 3 This Order shall take effect on the date it is confirmed and may be cited as the Swindon Borough Council Footpath 78 Wroughton Modification Order 2007.

## **DESCRIPTION OF PATH TO BE ADDED**

#### Footpath 78 Wroughton

The path which commences at Swindon Road between houses 69 and 71 at grid reference SU 415000 - 181729 (point A), and runs in a generally westerly direction and then in a west-south-westerly direction to Inverary Road at grid reference SU 414408 - 181503 (point B) approximate length 670 metres.

#### Footpath 78 Wroughton

The description of this path shall be:

From Swindon Road between houses 69 and 71 leading in a westerly direction and then in a west-south westerly direction to the boundary of the field with the Ridgeway School playing field and then across the playing field to Inverary Road. Approximate length: 670 metres Width: 2 metres. Limitations: Stile at point C
