MODIFICATION ORDER 2012**

This Order is made by Swindon Borough Council ("the authority") under Section 53 (2) (b) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Highworth Rural District Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(ii) of the 1981 Act, namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a highway shown on the map and statement as a highway of a particular description ought to be there shown as a highway of a different description.

The authority has consulted with every local authority whose area includes the land to which the Order relates.

Swindon Borough Council hereby orders that:

- 1 For the purposes of this Order the relevant date is 1 June 2012.
- 2 The Highworth Rural District Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
- 3 This Order shall take effect on the date it is confirmed and may be cited as the Swindon Borough Council Footpath 7 Blunsdon St Andrew and Footpath 8 Stratton St Margaret Modification Order 2012.

Stratton St Margaret		The length of footpath which commences at the parish boundary at OS grid reference SU 41664 18937, and runs southeast for 1399 metres to the A361 Highworth Road, 70 metres north of Catsbrain Farm, at OS grid reference SU 41802 18912, as shown marked B – C on the order map.	53(3)(c)(ii)

### VARIATION OF PARTICULARS OF PATH OR WAY

From the eastern end of the road U/C 3026, at its junction with the southern end of path 3 and the northern end of path 4, leading east-southeast to RB 8 Stratton St Margaret at the parish boundary.</p> <p>Length 685m. Width 3m.</p>
Stratton St Margaret	8	<p>The new description of this way shall be:</p> <p><u>RESTRICTED BYWAY:</u> <i>Kingsdown Lane</i>. From the junction of the parish boundaries of Blunsdon St. Andrew, Stanton Fitzwarren and Stratton St. Margaret, at the eastern end of RB 7 Blunsdon St Andrew, leading generally southeast along the parish boundary to the A.361 Highworth Road, 70 metres north of the entrance to Catsbrain Farm.</p> <p>Length 1.399km. Width 3m.</p>
