IMPORTANT ADVICE FROM YOUR ENVIRONMENTAL PROTECTION SERVICE ON THE SUBJECT OF SMOKE AND ASH/SMUTS etc.

(Please read all of the document)

Smoke from other people's bonfires can be a problem, whether it ruins enjoyment of your garden on a sunny day, spoils clothing that is hanging out to dry, or causes an odour in your home. This nuisance pack aims to provide you with detailed information about how we investigate bonfire smoke complaints and it attempts to answer some of the common questions that arise. There are legal remedies available in the form of the Environmental Protection act 1990 Statutory Nuisance Provisions, which can ultimately end in a criminal record for those causing unreasonable disturbance.

If a formal complaint is received; the Council has a legal duty to investigate the matter, and to serve a formal Abatement Notice if Statutory Nuisance is identified or suspected. In order to reach the best outcome for people who may continue living near each other for years to come however, we encourage people to try to contact the other party directly themselves to discuss the matter. This leaflet is provided for those persons suffering disturbance to give to those whose activities may be disturbing them to aid communication and understanding between them. We acknowledge that often, those causing the disturbance do not realise how intrusive it can be for others, and how damaging it can be to those around them, their health and wellbeing, and that those suffering the disturbance may not naturally be confident enough to tackle the issue with those causing the disturbance without assistance.

Bonfire smoke and the law:

It is an 'urban-myth' that there are laws allowing bonfires at certain times of the day, and outlawing them at other times. Any bonfire can cause Statutory Nuisance, and thus be prohibited at any time of day. Similarly; a well-managed bonfire in a rural area, for instance, that causes no disturbance to others is allowable. Bonfire night would be difficult if that were not the case!

In built up areas; it is almost impossible to prevent smoke from a bonfire drifting across other people's gardens or homes and causing a nuisance. As such our advice to people is to not have bonfires in urban areas - plant material can be composted and other materials can be taken to the recycling / refuse point at Darby Close. The Council also offers a 'bulky collection' service, which can be booked by calling (01793) 445501. Nobody 'has to' burn anything; there are other options for disposing responsibly of unwanted materials.

There are strong legal restrictions to prevent fires from causing health risks and nuisance:

- Smoke from a bonfire must not drift across a street or highway so as to cause a danger to traffic (this is enforced by the Police).
- Items must not be burnt on trade or business premises (including demolition sites) that will generate dark smoke (i.e. tyres, electrical cables, oil, polystyrene foam and other plastics). Doing so is an offence under the Clean Air Act 1993. This legislation is enforced by the Council's environmental protection team and offenders may be liable to prosecution. (Photographs can provide excellent evidence for this offence).
- Smoke from a garden bonfire must not be a nuisance or prejudicial to the health of other people. In legal terms it must not cause a statutory nuisance under the Environmental Protection Act 1990. This Act is enforced by Officers from the Council's environmental protection team.

The law does not define precisely what is or is not a nuisance, but in terms of smoke from a bonfire the following would help us in deciding whether the person was causing a statutory nuisance:

- 1. how often a particular neighbour lights bonfires,
- 2. whether or not the smoke is drifting into neighbouring properties or gardens,
- 3. the time of day / night,
- 4. the nature of the area (i.e. heavily built up or rural and sparsely populated),
- 5. The weather at the time of the fire, i.e. are neighbours trying to enjoy their gardens on a sunny day? Is washing hanging out to dry? Is the wind direction suitable?
- 6. d) The type of smoke. Dark smoke (i.e. from burning tyres, plastics, roof felt etc.) will almost inevitably amount to a nuisance because it contains chemicals that are prejudicial to health and has a very acrid odour. However, wood smoke alone can often cause nuisance.

What about wood burning stoves, open fires etc?

Wood burning stoves and open fires are capable of causing Statutory Nuisance too. Stoves and fireplaces installed by professional installers in accordance with current Building Regulations are however, unlikely to do so.

If we receive complaints that such an appliance is causing a Statutory Nuisance; we are compelled to investigate. Our first action in this case will be to check that the installation was done correctly; as an appliance not installed in accordance with current Building Regulations will most likely cause Statutory Nuisance at some point.

Our advice is to consider whether you live in an area appropriate for the use of stoves and open fires in the first place, and if content that this is the case; ensure that you use an accredited installer and that the appliance is installed in accordance with current Building Regulations.

So What Happens Next?

If we receive a formal complaint; we are compelled to investigate. We take complaints of Statutory Nuisance very seriously; and may use monitoring or recording equipment to gather evidence. If we think that Statutory Nuisance is being caused, we will serve a formal Abatement Notice; which makes it a criminal offence to continue to cause nuisance. We operate a 24hour a day response service; and enforcement officers may visit to witness episodes of nuisance at any time at short notice. Ultimately; we may prosecute offenders, and/or gain a warrant from the Court to force entry and abate the nuisance ourselves. Fines on conviction can be £5000 in residential premises, or £20,000 on premises where trade activities take place.
