Heating upgrades	<ul> <li>The Council has an annual programme to upgrade heating systems in its social housing stock (10,263 homes in total). The programme focuses on replacing less efficient noncondensing gas boilers with high efficiency appliances and distribution systems.</li> <li>The annual budget is approximately £1.8 million, and affects about 560 homes.</li> <li>Being predominantly urban, very few homes are heated by fuels other than gas. Our programme includes fuel swaps wherever practicable. ### Specific information requested by BEIS

### **Fuel Poverty**

- The authority has a part time dedicated Affordable Warmth Co-ordinator. We have no dedicated funding for delivery but look for external funding bids as they become available.
- Swindon Borough Council has a Fuel Poverty Strategy. This is currently being refreshed to run from 2017. There will be

- We run schemes as previously mentioned locally and to take advantage of national schemes, such as Warm Homes Discount and any available ECO funding. We use leads from our partners and our dedicated UNO software database to target suitable households. We also work with internal housing team to identify tenants needing assistance. We carry out evaluation of these activities to improve targeting and cost effectiveness.
- With the completion of our Safe & Warm scheme in 2016, we are now part of the Safe and Independent Living Scheme (SAIL), led by Dorset and Wiltshire Fire Service which targets vulnerable and low income households. We are also developing partnerships to provide a health and housing referral network.

• Building Control at Swindon Borough Council has no comments on this at the current time.

#### **Smart Meters**

- We have no funding to enable us to engage or support our residents, other than council tenants, with the Smart Meter roll out.
- We have provided links on our web-site to the Smart Energy GB web-site
- We are intending to write to Letting Agencies to remind them about Smart Meters and their availability to private tenants.

- We would be interested in developing schemes to get the best from the energy efficiency materials provided by Smart Energy UK. If smart meter data is made available then we would be keen to take advantage of this to assist our targeting and delivery of services.
- We feel that this work will be more appropriate as the Smart Meter role out evolves.

### Minimum Energy Efficiency Standards in the Private Rented Sector.

The Energy Act 2011 proposes that from April 2018 the minimum standard for private rented properties will be an Energy Performance Certificate rating of Band E.

- Swindon Borough Council is planning on integrating the Energy Performance Certificate requirements into its ongoing enforcement regime in the private rented sector. Swindon has an active Housing Standards enforcement team that carries out inspections of private rented properties constantly. The EPC requirements will be added to the suite of tools already used to assess properties, and will be enforced accordingly.
- Environmental Health officers in the enforcement team deal with the hazard of Excess Cold using the Housing Health and Safety Rating system (HHSRS) and supporting legislation. All properties that present with Category 1 hazards of this nature are remediated through enforcement processes, mitigating the hazard to well within Category 2 where possible. All properties inspected, whether the hazard of Excess Cold is complained of or not, are assessed for this hazard, and improvements enforced where appropriate. This will be extended to include an examination of the EPC in parallel with any inspection.
- Our private sector leasing scheme ensures that all properties used meet the Decent Homes Standard. Our Safe & Warm scheme continues to be promoted to landlords through targeted mail outs.
- Tenants' rights with regard to document production, and protection from retaliatory eviction when complaining of poor conditions, are communicated both to tenants and landlords at every opportunity.
- Swindon Borough Council encourages landlords to become members of the National Landlords Association.

	<ul> <li>Swindon Borough Council has partnerships with Dorset and Wiltshire Fire Service and Citizen's Advice, primarily through the SAIL scheme. We work with our Public Health colleagues promoting the health benefits of a warm and safe home, including falls prevention. This will continue for the foreseeable future.</li> <li>We intend to continue with the initiatives outlined, but delivery may be affected by dwindling resources.
