## Highways Act 1980 – Section 177

## Application for a licence to overhang part of the public highway Conditions of Licence made under Section 177 of the Highways Act 1980

- 1. Swindon Borough Council, as Highway Authority, may grant a Licence under Section 177 of the Highways Act 1980 permitting any part of a premises to overhang part of the public highway.
- 2. A Licence, under section 177 of the Highways Act 1980, to overhang the public highway must be obtained from Swindon Borough Council, as the Highway Authority, if any person, unless in the exercise of their statutory powers, wishes to construct a building over any part of the highway maintainable at the public expense (whether it is intended to span the highway or not), or alter a building so constructed.
- 3. No person shall use a building constructed or altered in pursuance of a Licence granted under s.177 of the Highways Act 1980 otherwise than in accordance with the terms and conditions of said Licence.
- 4. The Licensee must inform the Highway Authority within one month in the event of a change in ownership or occupancy of the premises.
- 5. Swindon Borough Council, as Highway Authority, may attach to any such Licence such conditions as considered necessary to ensure the safety and convenience of users of the highway and to prevent traffic being delayed, to prevent any obstruction and to protect the apparatus of statutory undertakers, sewerage undertakers and telecommunications undertakers.
- 6. Swindon Borough Council, as Highway Authority, may by notice served on the Licensee withdraw a Licence granted:
  - (a) on the expiration of any such period as specified in the notice, not being a period of not less than 7 days beginning with the date of service of the notice on the Licensee, if any such condition of the Licence is contravened by the Licensee;
  - (b) on the expiration of such period as may be so specified, being a period of not less than 3 months beginning with the said date, if the Highway Authority consider the withdrawal of the Licence is necessary for the purpose of the exercise of their functions as a Highway Authority.
- Where a Licence expires, is withdrawn or surrendered, Swindon Borough Council, as Highway Authority, may

   (a) remove the overhang to which the Licence relates and may recover expenses reasonably incurred by
  - them in so doing from the Last Licensee; or
    (b) if satisfied that the Last Licensee can, within such reasonable time as they may specify, remove the overhang, may authorise him to do so at his own expense.

The Last Licensee means the person who immediately before the expiration, withdrawal or surrender of the Licence was the Licensee or, if that person has died, his personal representatives.

- 8. The Licensee or the Last Licensee shall indemnify Swindon Borough Council, as Highway Authority, in respect of any Third Party claims or demands, in respect of injury, damage or loss arising out of:
  - (a) the presence of the overhang to which the Licence relates, or
    - (b) the execution by any person of any works authorised by the Licensee or by the Highway Authority as mentioned above in (6), or
    - (c) the execution by or on behalf of the Highway Authority of any works under subsection (b) as mentioned above in (6).
- 9. Except where agreed as part of the Licence no part of the highway may be closed, AT ANY TIME, without the consent of the Highway Authority.
- 10. The overhang(s) to which the Licence relates shall be properly maintained at all times during the continuance of the Licence and should not be allowed at any time to obstruct or interfere in any way with, or become a danger to the passage along the carriageway or footway.
- Persons authorised by the Highway Authority or any Statutory Undertaker, Sewerage Undertaker or Telecommunications Undertaker may at any time enter the part of the highway to which the Licence relates in order to carry out authorised works.
- 12. All works relating to the Licence must be carried out under the surveillance of the Highway Authority.
- 13. A single fee is charged in respect of legal and other expenses incurred in connection with the grant of a Licence and an annual fee is charged for the administration of the Licence during it's term.
- 14. All applicants will be notified of any fee before entering into the Licence.
- 15. Providing an application to renew an existing Licence, on its current terms, is received within 28 days of the expiry of its term then a renewal fee will be charged and the renewed Licence will commence from the day after the expiry of the previous Licence, application received outside of this 28 day period will otherwise incur the standard charge in force at the time for granting a new Licence.
