NOTICE OF BALLOT

This is to give notice that a ballot is to be held on the renewal of a Business Improvement District (BID) for Swindon Town Centre.

A ballot will be held in relation to renewing the Business Improvement District arrangements for a further five years. Details of the renewal are contained within the BID Business Plan which has been sent to you, under separate cover. In addition, the Business Plan and related documents are available from inSwindon BID Company, Level 4, Brunel Tower, Swindon, SN1 1LH and on the inSwindon website at www.swindontowncentre.co.uk/bidrenewal

The Ballot will be held entirely by post.

Ballot papers will be sent to those non-domestic ratepayers in the Swindon Town Centre that are eligible to vote on **8th December 2016** for return by no later than **5pm on Wednesday 1st February 2017** (the “day of the ballot”). Ballot papers received after this time will not be counted.
