

PUBLIC PATH DIVERSION ORDER

HIGHWAYS ACT 1980

FOOTPATH LN12 ORDER 2017

This order is made by Swindon Borough Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interests of the public it is expedient that the line of the way should be diverted.

BY THIS ORDER:

1. The public right of way over the land situate at the Great Western Hospital, Commonhead, in the parish of Liddington, and shown by a bold continuous line on the map contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after forty two days from the date of confirmation of this order.
2. The public utilities have been consulted and no apparatus will be affected by the making of this order.
3. There shall at the end of forty two days from the date of confirmation of this order be a public footpath over the land situate at the Great Western Hospital, Commonhead, in the parish of Liddington, and at Badbury Park, in the parish of Central Swindon South, described in Part 2 of the Schedule and shown by a bold broken line on the map attached to this order.

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

The length of Footpath LN12 in the parish of Liddington, as shown on the order map by a bold continuous line from point A at OS grid reference SU19224 81996, at the southern perimeter of the Great Western Hospital grounds and 40 metres west of the northbound exit slip road of the A419 trunk road, leading east-northeast for 30 metres, north for 20 metres, and east for 10 metres to point Z at OS grid reference SU19258 82003, at the slip road, immediately south of the emergency entrance to the hospital grounds.

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

A length of footpath in the parishes of Liddington and Central Swindon South, as shown on the order map by a bold broken line from point A at OS grid reference SU19224 81996, at the southern perimeter of the Great Western Hospital grounds and 40 metres west of the northbound exit slip road of the A419 trunk road, leading south for 350 metres to point B at OS grid reference SU19218 81689 at the parish boundary, continuing south then west to point C, north to point D and generally west-southwest to point E at OS grid reference SU18967 81588 at Day House Lane, south of Badbury Wick.
