# The CIL Examination and Adoption Process

## The Inspector

Planning Inspector; Mr. Mike Fox BA (Hons) DipTP MRTPI was appointed to undertake an independent Examination of the Community Infrastructure Levy Draft Charging Schedule.

A briefing note was prepared by the Inspector which provided information on his role and the format of the Examination.

### The Programme Officer

Mr. Ian Kemp acted as Programme Officer for the Examination. His role was to assist the Inspector, Borough Council and any interested party with the administration of the Examination and was the first point of contact for any procedural advice or queries. Mr. Kemp was an impartial Officer of the Examination and was not involved in the preparation of the Draft Charging Schedule.
