THE SWINDON BOROUGH COUNCIL (SOUTHERN CONNECTOR ROAD, NEW EASTERN VILLAGES) COMPULSORY PURCHASE ORDER 2019

SECTION 226(1)(a) TOWN AND COUNTRY PLANNING ACT 1990 (AS AMENDED) THE ACQUISITION OF LAND ACT 1981

SWINDON BOROUGH COUNCIL (in this order called "the acquiring authority") makes the following order:

- Subject to the provisions of this order, the acquiring authority is, under section 226(1)(a) of the Town and Country Act 1990 (as amended), hereby authorised to purchase compulsorily the land described in paragraph 2 for the purpose of facilitating the carrying out of development, specifically, the construction and delivery of the Southern Connector Road, New Eastern Villages, Swindon (known as the SCR).
- 2. The land authorised to be purchased compulsorily under this order is the land described in the Schedule and delineated and shown coloured pink, coloured blue, coloured orange, coloured brown (plots 2/6e and plots 2/9g), and hatched pink, on the map prepared in duplicate, sealed with the common seal of the acquiring authority and marked "Map referred to in Swindon Borough Council (Southern Connector Road, New Eastern Villages, Swindon) Compulsory Purchase Order 2019".
- 3. Parts 2 and 3 of Schedule 2 to the Acquisition of Land Act 1981 are hereby incorporated with this order subject to the modifications that references in the said Parts 2 and 3 to the undertaking shall be construed as references to the buildings or works constructed or to be constructed on that part of the land authorised to be purchased on the said map.
