

APPLICATION TO EXTINGUISH A PUBLIC RIGHT OF WAY

Highways Act 1980 S.118

IMPORTANT: No authority for the extinguishment of a public right of way is conferred unless and until an order made under Section 118 of the above Act has been confirmed. Any preliminary obstruction or interference with the public right of way concerned is not only an offence but may invalidate the application.

Section 118 of the Highways Act 1980 permits the extinguishment of a public right of way on the grounds that it is not needed for public use. Any obstruction of the right of way which prevents its use by the public must be disregarded insofar as it has discouraged public use. *Any premature closure is unauthorised and may invalidate an application.*

Section 5: Statement

I/We* declare that the current route of the footpath/bridleway/restricted byway* to be extinguished is not obstructed in any way and is fully available for public use, and I/we* undertake that it shall not be obstructed in any way before the order comes into operation.

I/We* agree to pay the Swindon Borough Council all reasonable costs incurred in the preparation and making of the order.
