

NOTICE OF PUBLIC PATH ORDER
TOWN AND COUNTRY PLANNING ACT 1990, SECTION 257
AND PARAGRAPH 1 OF SCHEDULE 14
SWINDON BOROUGH COUNCIL
PUBLIC FOOTPATH 2, PARISH OF CENTRAL SWINDON SOUTH
ORDER 2022

On 4 October 2022 Swindon Borough Council confirmed the above order.

The effect of the order as confirmed will be to divert the public footpath running from Point A on Day House Day at OS grid reference SU19098137, approximately 210 metres north west of the centre of the A419 bridge over Day House Lane in a generally south south easterly direction through Points Y and V for approximately 340 metres to Point B at OS grid reference SU18958104, approximately 85 metres west of the boundary fence of the Highways Maintenance Depot and create the alternative footpath from Point Z on Day House Lane at OS grid reference SU19058139, approximately 240 metres north west of the centre of the A419 bridge over Day House Lane, in a generally south westerly and then south south easterly direction through Point Y, then a south westerly direction to Point X, and then south easterly and south south westerly to Point W at OS grid reference SU19028103, approximately 25 metres west of the boundary fence of the Highways Maintenance Depot, a total distance of approximately 435 metres, as shown on the order map.

A copy of the order and the map may be seen free of charge at the One Stop Shop, Wat Tyler House, Beckhampton Street, Swindon, from 9am to 5pm on Mondays and Wednesdays to Fridays and 9am to 4pm on Tuesdays. Copies of the order and map may be bought there at the price of £15. The order and order map can also be viewed on the public rights of way pages of the Swindon Borough Council website (www.swindon.gov.uk/publicpathorders).

The order came into force on the 4 October 2022 but if a person aggrieved by the order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Town and Country Planning Act 1990, as amended, or on the ground that any requirement of the Act, as amended, or any regulation made under it has not been complied with in relation to the confirmation of the order, he or she may apply to the High Court for any of these purposes under section 287 of the Town and Country Planning Act 1990 within 6 weeks from the date on which notice is first published as required by paragraph 8 of Schedule 14 to that Act.
