

**NOTICE OF PUBLIC PATH ORDER**  
**TOWN AND COUNTRY PLANNING ACT 1990, SECTION 257**  
**AND PARAGRAPH 1 OF SCHEDULE 14**  
**SWINDON BOROUGH COUNCIL**  
**PUBLIC FOOTPATH 9, PARISH OF WROUGHTON**  
**ORDER 2022**

The above order was made on 16 June 2022. The effect of the order will be to divert the public footpath running from Point A at OS grid reference SU13428268, at Mill Lane, in a generally east north easterly direction to Point B at OS grid reference SU13708277, at Foxham Way, a distance of approximately 280 metres, and create the alternative footpath from Point C at OS grid reference SU13418265, at Mill Lane, in a generally easterly then southerly, south westerly and south easterly direction through Point E to Point F, then continuing in a generally easterly direction to Point G and then in a generally north north easterly direction to Point D at OS grid reference SU13748274, at Foxham Way, a total distance of approximately 465 metres, as shown on the order map.

A copy of the order and the map may be seen free of charge at the One Stop Shop, Wat Tyler House, Beckhampton Street, Swindon, from 9am to 5pm on Mondays and Wednesdays to Fridays and 9am to 4pm on Tuesdays. Copies of the order and map may be bought there at the price of £15. Any representations about or objections to the order may be sent or delivered in writing addressed to the Rights of Way Officer, Swindon Borough Council, Highways and Transport, 5<sup>th</sup> Floor Wat Tyler House West, Beckhampton Street, Swindon SN1 2JH, not later than 15 July 2022. Please state the grounds on which they are made.

If no such representations or objections are duly made, or if any so made are withdrawn, Swindon Borough Council may confirm the order as an unopposed order. If the order is sent to the Secretary of State for the Environment for confirmation any representations and objections which have not been withdrawn will be sent with the order.
