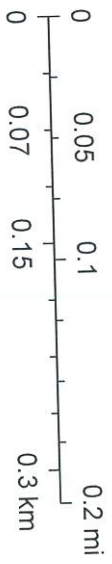

Land at Liddington(SU 211 806)



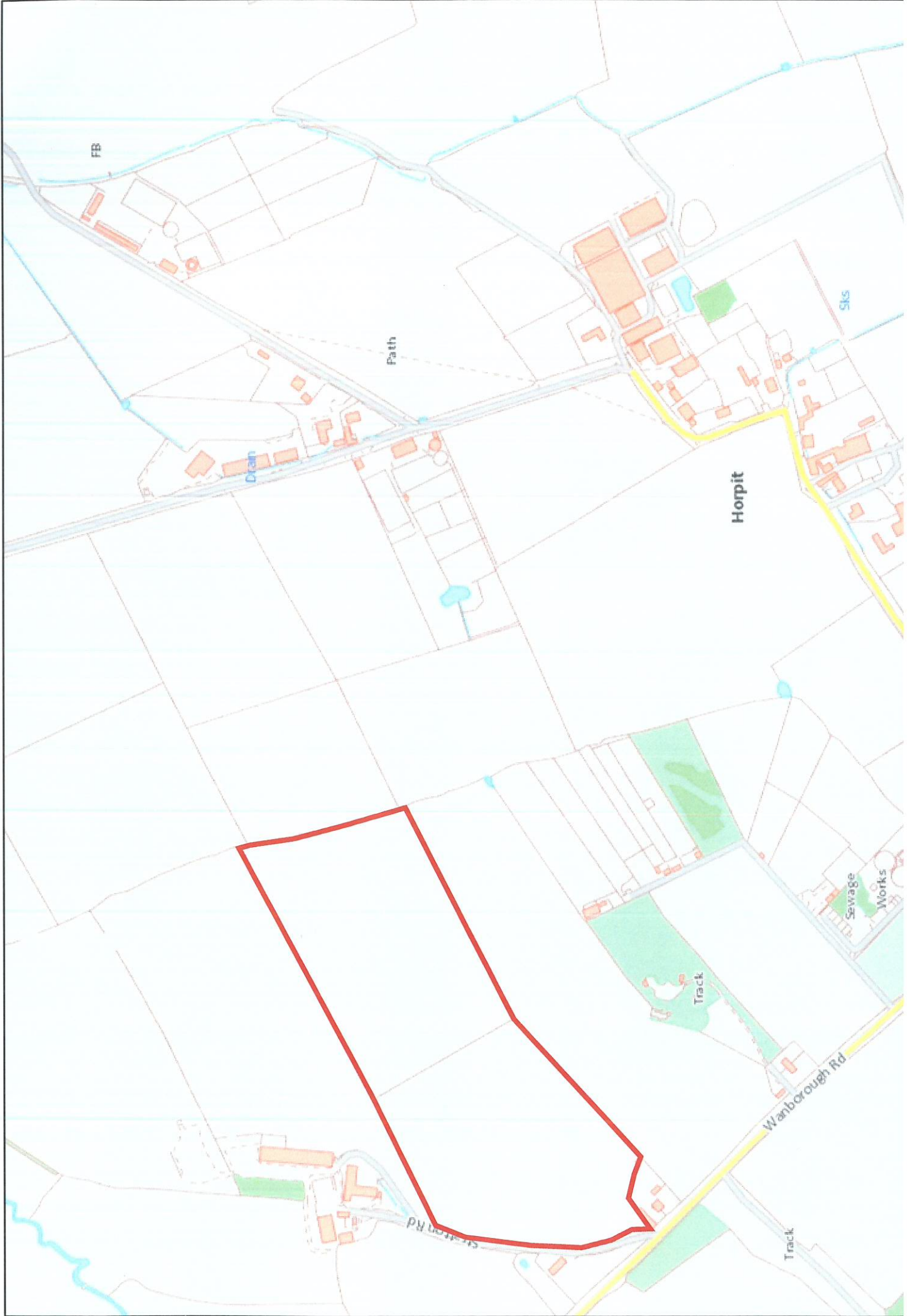

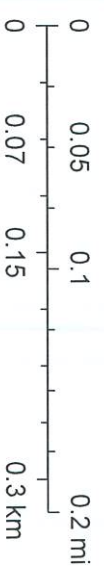
