## Medical Requirements for Hackney Carriage and Private Hire Drivers

### NOTES FOR APPLICANTS

The Group 2 Medical Examination is to be completed by the applicants own General Practitioner (GP) or another GP in the same practice or a GP in another practice, provided they have access to the applicants full NHS records at the time of the examination.

This Certificate is not one which must be issued free of charge as part of the National Health Service. The Council accepts no liability to pay for it, and unless any other arrangements have been made, the applicant is to pay the fee charged.

#### **A certificate is required:**

- (1) At the time of the first application for a licence.
- (2) At the age of 47 and every 3 years thereafter.
- (3) At the age of 65 and every year thereafter.

The Council may withhold the issue of a driver's licence pending receipt of a satisfactory medical report.

As a taxi or private hire vehicle driver driving members of the public in all weathers, day or night, you are required to have the same standards of fitness as any other public service vehicle driver. These are higher than for those who hold only the ordinary driving licence.

#### **For instance:**

You cannot hold a public service vehicle driver's licence if you have had even one epileptic attack in the last 10 years or have been on medication for epilepsy in the last 10 years.

Heart and blood pressure problems may be a bar.

You should not be needing insulin injections for diabetes.

If you have had a stroke, unexplained loss of consciousness, severe head injury with continuing after effects, major brain surgery, Parkinson's disease, or multiple sclerosis, you will not be suitable.

You should not be being treated for mental or nervous problems, and if you have had drink or drug problems or suffered mental illness in recent years you will also not be suitable.

Your vision is particularly important, and should reach a certain standard in each of both eyes. Double vision, tunnel vision, or having only one eye is a bar.

Applicants should be numerate and literate.

If your hearing is so bad that you cannot use a telephone in an emergency you will be unsuitable.

There are certain other medical conditions which make vocational driving inadvisable and your doctor should be able to advise you.

Referral to a specialist may be necessary in some cases.

## NOTE TO MEDICAL PRACTITIONER

Taxi and Private Hire drivers drive at all times of day and night in all weather conditions. They should be considered as professional drivers alongside drivers of public service vehicles. Standards of fitness should be based on PSV standards. In completing this certificate medical practitioners are asked to have regard to the recommendations by the Medical Commission for Accident Prevention in their booklet "Medical Aspects of Fitness to Drive" or to the notes for the guidance of Doctors conducting those examinations prepared by the British Medical Association.

### ADDITIONAL NOTES

#### VISION

Applicants who wear glasses should be advised always to carry a spare pair.

Monocularity is a bar.

In cases of amblyopia where there is doubt, it is advisable to obtain the opinion of an ophthalmologist.

Uncorrected static visual acuity must be at least 3/60 in each eye, and the corrected vision should be 6/9 in one eye and 6/12 in the other or better.

#### LITERACY

Applicants should be literate.

#### MENTAL HEALTH

Psychiatric Disorder. Some significant conditions rendering a driver unfit include depressive psychosis, manic depression, hypo-mania, neurosis on treatment, psychotic disorder, personality disorder, psychopathic disorder, alcohol and/or drug addiction.

#### EPILEPSY

Drivers must first hold an ordinary driving licence and in addition must have been fit free and off medication for 10 years. They must see a neurologist who can confirm that the individual is not liable to epileptic seizure.

Patients with lung cancer are recommended not to drive professionally for five years, even after treatment, due to possible risk of cerebral secondaries provoking epilepsy.
