## NOTICE OF MAKING AN ORDER PUBLIC PATH DIVERSION ORDER HIGHWAYS ACT 1980 SWINDON BOROUGH COUNCIL PUBLIC FOOTPATH 7 STRATTON ST MARGARET NUMBER 2 ORDER 2023

On 20 December 2023 Swindon Borough Council confirmed the above order made under section 119 Highways Act 1980.

The effect of the order as confirmed is to divert the public footpath in two sections

- i. Section 1 from Point A at OS grid ref SU17408879 approx 110m north east from the junction of Public Footpath 7 and Kingsdown Road leading generally north north eastwards, then northwards and then north westwards through Point B at OS grid ref SU17418911 to Point E at OS grid ref SU17358915 at Restricted Byway 8 Stratton St Margaret, Kingsdown Lane, a total distance of approx 430m to a line running from Point A leading generally north east wards and then curving round to head generally north westwards through Point Y at OS grid ref SU17438911 and Point C at OS grid ref SU17418913 to Point X at OS grid ref SU17378916 at Restricted Byway 8 Stratton St Margaret, Kingsdown Lane, a total distance of approx 450m as shown on the order map.
- ii. Section 2 from Point B at OS grid ref SU17418911 approx 75m south east from the junction of Public Footpath 7 and Kingsdown Lane at Point E at OS grid ref SU17358915 leading generally northwards to Point C at OS grid ref S17418913 and then north eastwards to Point D at OS grid ref SU17448918 at Restricted Byway 8 Stratton St Margaret, Kingsdown Lane, a total distance of approx 80m to a line running from Point Y leading generally north wards, north eastwards and northwards to Point D a total distance of approx 75m as shown on the order map.

The order comes into force on 2 February 2024 but if a person aggrieved by the order wishes to question its validity, or that of any provision contained within it, on the grounds that it is not within the powers of the Highways Act 1980, as amended, or on the grounds that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the order, that person may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 42 days of the date of this notice make an application to the High Court
